John & Mary Alford Pavilion

The culmination of two years of construction was celebrated on July 22, 2007, as Licking Memorial Hospital (LMH) unveiled the 100,000-square-foot John & Mary Alford Pavilion with a grand ribbon-cutting ceremony. Pre-ceremony excitement built up over the preceding months as many community groups were given tours of the construction, and the entire public was invited to a gala Community Open House. The celebration was amplified as the construction project was completed on time and on budget.

In April, the Pavilion was formally named after John and Mary Alford in recognition of a \$3.5 million contribution from their daughter and son-in-law, Barbara and Michael Cantlin. The Alfords had been strong supporters of the community and Licking Memorial Hospital. John served as Chairman of the Licking County Hospital Commission and was instrumental in the construction of the Hospital at its current location on West Main Street.

The public response to the Pavilion's facilities has been gratifying. Both local and out-of-town patients and professionals have expressed their admiration of the high quality of care, caliber of employees and equipment LMH has to offer, and have rated LMH very favorably in comparison to hospitals in much larger cities. LMH is now able to offer safer, more advanced surgical procedures that are not available at most other Ohio hospitals.





Openings

The new Emergency Department on the first floor of the John & Mary Alford Pavilion opened with a ribbon-cutting ceremony on July 23, 2007. Its technology-intensive patient examination rooms were designed with details that offer more space, comfort and privacy, while increasing efficiency.

The Surgery Department hosted a ribbon-cutting ceremony to open its new location in the John & Mary Alford Pavilion on August 10, 2007. The large operating rooms and state-of-the-art technology have put LMH in the forefront of surgical facilities of any other hospitals. In November, a "cut-through" was completed to allow access between the "old" and "new" Hospital areas.

Two physician practices opened on August 26, 2007, with a ribbon-cutting ceremony for the newly-constructed North Newark location at 270 Goosepond Road. The building houses the practices of Dermatologist J. Michael Holsinger, D.O., and Family Practice Physician Angela Morris, M.D.

Hospital food services improved at Licking Memorial Hospital on November 30, 2007, as the redesigned Cafeteria was unveiled during a ribbon-cutting ceremony. New menu items include an omelette bar, made-to-order pasta selections, panini sandwiches, and fresh pizza. In addition, the dining area was redecorated with new furniture.



Changes

In addition to building all-new Surgery and Emergency facilities in the John & Mary Alford Pavilion, many existing areas of Licking Memorial Hospital (LMH) were rejuvenated with new equipment and furnishings. The result is a sense of continuity throughout the entire Hospital, without a noticeable difference between the existing and new areas.

- An updated Meditech bedside medication verification system was implemented in 2007. It uses barcode technology to verify the right medication is going to the right patient at the right time in the correct dosage.
- Hospital employees began using Vocera, a wireless voice messaging system to improve communications throughout the Hospital.
- New, adjustable beds were installed in Maternal Child's Labor and Delivery rooms.
- New waiting room furniture for Registration and the GI Lab was delivered in May 2007.
- Additional private rooms were added at LMH during 2007.
- New carpet throughout the building has given LMH a fresh look, and updated artwork in the existing Hospital helps to blend the older areas with the new Pavilion.

In December, LMHS announced the opening of Licking Memorial Heart Center, located at 42 Messimer Drive in Newark. At Licking Memorial Heart Center, Cardiologist Imtiaz Ahmed, M.D., F.A.C.C., is working in cooperation with other contracted physicians from MidOhio Cardiology and Vascular Consultants in conjunction with Riverside Methodist Hospital of OhioHealth. Because of these physicians' special training, LMH is now able to offer interventional cardiac services to patients locally, rather than requiring them to travel to Columbus.

Licking Memorial Health Systems increased its scope of services in 2007 to include new specialties and programs that offer a "whole patient" approach to patient care. In February, Licking Memorial announced the addition of Licking Memorial Hospital Pastoral Care to address and coordinate patients' spiritual needs. Pastoral Care Director Jeff Smith hosted ministers from across Licking County to a breakfast at the Hospital to discuss the new program. The ministers received special green photo badges that identify them as members of the clergy.

Five Health Professionals practices opened in 2007 in addition to the Licking Memorial Heart Center. Licking Memorial Urology reopened with Urologist William A. Stallworth, M.D., providing patient care. The office is located at 1272 West Main Street, Building 6, in Newark. Licking Memorial Neurology reopened with Jason L. Barfield, M.D., providing patient care. The office is located at 120 McMillen Drive in Newark. Plastic Surgeon James Jeffries III, M.D., F.A.C.S., joined Licking Memorial Health Professionals and practices at Licking Memorial Reconstructive & Cosmetic Services located in the upper level of 1272 West Main Street, Building 2, in Newark. The North Newark location opened with two pratices – Licking Memorial Dermatology with J. Michael Holsinger, D.O., and Licking Memorial Family Practice with Angela Morris, M.D.

Palliative care services were added as part of the Hospital's patient care in 2007 through the Hospice of Central Ohio. These services are provided by Maria Mapa, D.O., and Carl D. Waggoner, M.D.

In October, LMH initiated a Courtesy Shuttle service to patients and visitors. The free shuttle offers quick and convenient rides between the parking lots and the Hospital's main and Pavilion entrances.

In May, Maternal Child Services initiated a way of providing customized care to new parents. A gourmet candlelight dinner for two is provided in the mother's room with a choice of select entrées.

Licking Memorial Hospital began a program of Massage Therapy in 2007. The services are available to patients who have a doctor's referral.

In 2007, LMHS laid the groundwork for a new approach to customer service. During an initial retreat, representative staff members collaborated on ways of improving service and increasing patient satisfaction.





















Community Outreach

Believing the mission to improve the health of the community extends beyond Hospital walls, Licking Memorial Health Systems (LMHS) further demonstrates its commitment to the community by encouraging healthy lifestyles and teaching about health issues. The Public Relations Department keeps the public informed about LMHS advances and health trends through frequent press releases, advertising, the monthly Community Report Card, which compares LMHS measures with national averages, and the monthly Community Connection newsletter, which is mailed directly to more than 53,000 homes.

The Health Systems hosts a full calendar of events that are very well received by the community. LMHS also supports other organizations' events that promote wellness. LMHS sponsors dozens of school, youth and church programs around Licking County, as well as many social service organizations' special events.



Fundraising

2007 was a vital fundraising year at Licking Memorial Health Systems. The John & Mary Alford Pavilion at Licking Memorial Hospital (LMH) was constructed without any tax revenue assistance. In order to remain fiscally responsible and still include expensive state-of-the-art technology and aesthetic amenities in the Pavilion plans, the LMH Development Department worked diligently to secure special contributions to offset the costs. Charitable contributions to LMH are used to purchase equipment and fund programs. The contributions are not used for salaries or general operating expenses.

The final of five Founder's Level gifts (\$100,000 or more) was announced in 2007 to join the four other Founder's Level gifts previously received in 2006. Local businessman Howard LeFevre's contribution funded a large electronic wall in the Pavilion's main entrance lobby. The nine-screen video wall is used to display images and messages for Hospital patients and visitors.

The Cornerstone Club is comprised of community members who contribute \$100 or more to LMH. Donations from 141 Cornerstone Club members in 2007 raised \$17,550 toward a CT scanner in the Pavilion's new Emergency Department. Cornerstone Club members are awarded a piece of the Main Street Collection every time they achieve a milestone level of giving. The latest addition to the Main Street Collection, a likeness of the John & Mary Alford Pavilion, was unveiled to honor donors who have reached the \$4,500 level of giving.

Physicians at LMHS have their own opportunities to lend financial support. The Caduceus Society is a prestigious organization made up of physicians who pledge a gift of \$10,000 or more over a period of 10 years. The Caduceus Society increased by eight memberships in 2007, bringing the total number of memberships to 31. The new memberships include: Dr. and Mrs. Donald Adams; Dr. George and Sandy Andrews; Dr. and Mrs. James Jeffries III; Dr. Elizabeth Koffler; Drs. Alana and Jeff Milton; Mr. Gregory and Dr. May-Lee Robertson; Dr. David and Pamela Subler; and Dr. Evelina Worwag.

The John Alford Fellowship added one new member in 2007 as Anne Peterson, Vice President of Human Resources and Support Services, increased her level of giving. There are currently 19 members of the John Alford Fellowship who pledged a contribution of at least \$25,000 over 10 years. The Schaffner Society received 10 new memberships in 2007, pledging at least \$10,000 over 10 years. The Schaffner Society has a total of 91 memberships.

The annual Licking Memorial Golf Gala took place at the Granville Golf Course on June 18, with Bob and Joan Kent serving as honorary chairs. The first place team of the tournament was Crowe Chizek & Co., whose members included Brady Burt, Chris Helms, Jim Slivanya and Paul Turner. Presenting sponsors (\$2,500) of the Golf Gala were: MedBen and Park National Bank. Event sponsors (\$1,000) were: Dynamix Engineering, Ltd.; Fifth Third Bank; Jerry McClain Companies; Limbach Company, LLC; National City Bank; OhioHealth Corporation; Red Vette Printing; Sauer Incorporated; Stedman Floor Company, Inc.; The Shepherd Foundation; and Turner Construction Company. More than 120 golfers played in the Licking Memorial Golf Gala, which brought in \$40,284.20 to benefit the Health Systems.

2007 was a milestone year for PRIDE (Providing Resources In Dedicated Employees). A three-year campaign from July 2004 to July 2007 raised \$330,000 toward the Pavilion's new Emergency Department waiting area. The next three-year commitment, PRIDE Idol: Season Two, kicked off with a week-long extravaganza of employee talent shows, treats and incentives. Over \$1 million has been donated by PRIDE members since 1987. As of December 2007, PRIDE had 558 members.



















Employment

In addition to leading Licking County's health care industry, Licking Memorial Health Systems further demonstrates its community stewardship by providing stable employment in a progressive environment. Licking Memorial Health Systems employs approximately 1,630 full-and part-time employees and approximately 150 staff physicians. According to a report by the Licking County Chamber of Commerce, LMHS is the largest employer in the county.

LMHS builds its team approach by including employees in celebrations throughout the year. In 2007, employees received complimentary lunches to celebrate the Hospital's 109th birthday, the Top 100 Hospital award announcement, National Hospital and Healthcare Week, Thanksgiving Day and the winter holiday party.

LMHS employees are recognized for their years of service at each five-year increment with a generous bonus check. On May 16, the annual employee recognition dinner took place at Longaberger Golf Course. Lorraine Berry of LMH Operating Room and Don Jones of Licking Memorial Physical Therapy were each honored for their 40 years of employment.

The Dining with the Stars program recognizes employees who have provided excellent customer service. Monthly, the Health Systems hosts a gathering of employees whose exemplary care merited special notice from patients or their families. Every other month, LMHS President and CEO Robert A. Montagnese hosts a Birthday Celebration forum that includes employees who are celebrating birthdays. During the forums, the employees have an opportunity to discuss Health Systems' issues and receive a gift.
