Beginning July 9, outpatient surgical services will be available at Licking Memorial Hospital (LMH) -Tamarack, located at 2000 Tamarack Road in Newark. Licking Memorial Health Systems (LMHS) opened LMH – Tamarack in January with available outpatient services including the LMH



Wound Clinic, Outpatient Laboratory and select Pre-Admission Testing. The Ohio Department of Health recently licensed LMH - Tamarack as a surgical facility, which will allow LMHS to provide additional services at the new location. Eye surgeries will be among the first procedures performed at LMH - Tamarack, but plans to expand surgical offerings at the facility will include podiatric, urologic and minor orthopedic procedures.

Active•Fit Youth Wellness Program Celebrates First Anniversary

The Active•Fit Youth Wellness Program is wrapping up an incredibly successful inaugural year of promoting healthy lifestyles and habits for Licking County children. Over the past 12 months, more than 1.100 children, ages 6 to 12, enrolled in the free program to learn about the benefits of exercise, healthy eating and proper rest. A collaborative effort between Licking Memorial Health Systems (LMHS) and Newark Advocate Media, the Active•Fit Program motivates children to choose personal health and fitness goals, and lays the foundation for a lifelong commitment to personal wellness.



The Pataskala Health Campus hosted the first Active•Fit event of the summer with inflatable fun areas and games for Licking County youth.

The Active•Fit Program was created in response to the rise of childhood obesity throughout the United States. Recognizing that awareness and education were not enough, LMHS and Newark Advocate Media developed an idea to combine fun events, great prizes and educational activities into a free, goal-based program that motivates youth to make healthy changes. Each four-month period, Active•Fit participants choose eight fitness- and nutrition-related goals and enter their progress into their personal record at www.ActiveFit.org. Children who attain their goals with the help of a parent, guardian or mentor qualify for an incentive prize drawing.

Parents and teachers have given Active•Fit enthusiastic feedback because of their children's renewed excitement toward active and healthy lifestyles. "The Active-Fit Program makes it easy for children to take control of their health and fitness by choosing the goals they want to achieve each period," said Katey Shane of Utica, mother of Period 2 grand prize winner Mandie Farabee. "By being active and making better choices about what she eats and drinks each day, Mandie has lost 15 pounds since joining Active-Fit. Because of her success, her cousins also joined the program and they are all working together to meet the goals that they set for Period 3. It has been fun for Mandie to record her progress each day, which kept her on track to complete her goals. As her mother, I am thrilled to see how much better Mandie feels about herself through the confidence she has gained as a participant in the Active•Fit Program."

Due to the positive impact that the Active•Fit Program made locally, it earned three prestigious honors. Jackson Healthcare designated the initiative as a Program of Promise through its nationwide Hospital Charitable Services Awards. Active•Fit also was named as a finalist for Columbus Business First's annual Health Care Heroes Community Outreach Award and the Gannett Company's Greater Good Award. Uniquely encompassing components of adult participation, online tracking, activity, nutrition education and free events, Active•Fit is the first initiative of its kind in the United States, and has captured the attention of outside organizations interested in modeling the program.

"Even in its infancy, the Active•Fit Program produced measurable results toward improving the health of the community," said LMHS President & CEO Rob Montagnese. "Other hospitals and health systems have inquired about adapting the successful Active•Fit template

for their own communities. It is exciting to think that our efforts to reduce childhood obesity in Licking County could become a model to promote healthy lifestyles in children throughout Ohio and, perhaps, the nation."

As part of Active•Fit Period 3, which began May 1 and continues through August 31, LMHS invited community members to the Pataskala Health Campus on Saturday, June 8, for a celebration of summer fun for the entire family. The festivities, which were offered free of charge, began with an Active•Fit event featuring inflatable fun areas and games, and concluded with an outdoor screening of Disney's Wreck-It Ralph at the first of three LMHS Family Movie Night events. All attendees enjoyed complimentary healthy snacks and beverages, as well.

In between the two events, LMHS honored the Active•Fit prize winners from Period 2. Participants in the youth wellness program who completed their fitness goals between January 1 and April 30 were entered into a special drawing. Winners and their families gathered at the Pataskala Health Campus to receive their prizes and celebrate their achievements. Prizes included Dick's Sporting Goods gift cards, iPod Nanos with fitness software, Nike shoes, bicycles and Xbox 360s with Kinect and fitness games.

Each period of the Active•Fit Program features exciting events and opportunities for children to get active and learn about their health. 

LMH Receives Award for Cancer Patient Care

Licking Memorial Hospital (LMH) recently received the 2012 Outstanding Achievement Award from the American College of Surgeons' Commission on Cancer (CoC). LMH is one of a select group of only 79 healthcare facilities in the U.S. with accredited cancer programs to receive this national honor. The award recognizes cancer programs that achieved excellence ratings for providing quality care to cancer patients based upon on-site surveys that were conducted last year.

Debbie Young, LMH Vice President Patient Care Services, said that the Hospital's emphasis is to provide cancer patients with state-of-the-art treatments, while accommodating their other needs, as well. She stated, "Our Hematology/Oncology staff stays abreast of current treatment protocols and advancements, as well as any clinical trials that may benefit our patients. For cases that require surgery at another hospital, we can usually coordinate pre- and post- surgical treatment at LMH to save the patient from a long commute. A cancer diagnosis completely disrupts the patients' lives, so we look for ways to make the treatment period a little easier for them."

The CoC created the award to raise awareness about the importance of providing quality cancer care at healthcare institutions throughout the U.S. In addition, it is intended to:

- Motivate other cancer programs to work toward improving their level of care
- Facilitate dialogue between award recipients and healthcare professionals at other cancer facilities for the purpose of sharing best practices
- Encourage honorees to serve as quality care resources to other cancer programs
- Educate cancer patients on available quality-care options

LMH's cancer program was evaluated on 29 program standards within four cancer program activity areas:

- Cancer committee leadership
- Cancer data management
- Clinical services
- · Quality improvement

LMH's program was further evaluated on eight commendation standards. To be eligible, all award recipients were required to receive commendation ratings in at least seven of the commendation standards in addition to receiving a compliance rating for each of the 29 program standards.

However, Licking Memorial Hospital (LMH) is committed to assisting patients throughout every step of their journey. Liz Nye, R.N., a member of the LMH nursing staff for more than 30 years, serves as the Oncology Nurse

Navigator to act as an advocate and educator in all aspects of cancer care. Nurse Navigator services are available at no cost to LMH cancer patients and their families or caregivers.

The Oncology Nurse Navigator provides patients with information about all available options for their cancer treatment, while helping maintain their quality of life. Liz works closely with physicians, social workers, therapists, dietitians, and financial assistance advisors to ensure cancer patients receive the best care possible.

Navigator services include:

- Diagnosis and treatment education
- Connecting patients with available community resources for additional services
- Helping to organize ongoing treatment
- Assisting in scheduling follow-up care

- Serving as a liaison between patients and their medical team

The Nurse Navigator also helps coordinate needed services, such as:

Picnic Celebrates Community's Cancer Survivors

In recognition of National Cancer Survivors' Day, Licking Memorial Health Systems (LMHS) hosted a Cancer Survivors' Picnic on June 9. Former and current cancer patients were invited, along with their family and friends, to enjoy a free outdoor picnic and program at Licking Memorial Hospital (LMH) that included live music by the Ultrasounds jazz band, and raffle prizes. The event culminated with an aerial commemorative photo of the cancer survivors and the release of balloons that were tagged, "I am a survivor."

LMHS President & CEO Rob Montagnese greeted guests with encouraging news about cancer care. "Major advances in cancer prevention, early detection, and treatment have resulted in longer survival," he stated. "The five-year relative survival rate for all cancers diagnosed between 2002 and 2008 is 68 percent, up from 49 percent between 1975 and 1977. The National Cancer Institute estimates that last year, approximately 13.7 million Americans were living with a history of cancer. Within the next 10 years, the number of survivors is expected to increase to 18 million. The prognosis continues to improve each year."

Approximately 375 community members attended LMHS' third annual Cancer Survivors' Picnic. Jacqueline Jones, M.D., of Licking Memorial Hematology/Oncology, emphasized the important role that friends and family have in a cancer patient's treatment. "Hearing that word, 'cancer,' devastates you until you can get to the point where you can fight." Dr. Jones said. "There are so many details to be arranged, even though you may not be feeling strong enough to take care of them. Along with the physicians, nurses,

radiologists, and other healthcare providers, family members and friends are part of the important support network that each cancer patient relies on to help through the difficult times. At LMH, we now have an Oncology Nurse Navigator who can also help cancer patients find services and resources that are available to ease their burden."

LMH has nearly completed a \$3.5 million 2013 Radiology Initiative that will benefit many patients, including those with cancer diagnoses. The project includes equipment upgrades and replacements, along with facility remodeling in the Radiation Department. Ultrasound images, in both the Radiology Department and Vascular Lab, will be depicted in a 3-dimensional format, providing a "GPS" component to guide instruments during biopsies. In addition, many women will be able to avoid surgical breast biopsies as LMH's Women's Health Center will add stereotactic biopsy equipment that allows the testing to be completed in an outpatient setting. The Initiative is expected to be completed by the end of 2013.

The Radiology Initiative is taking place just after LMH recently completed the \$1.5 million investment to renovate the Hematology/Oncology Department on the fifth floor. The renovation's improvements included comfortable private chemotherapy infusion rooms, additional exam rooms, an updated chemotherapy mixing room, a centrally located staff office, and an expanded registration and waiting area that features the custom 250 gallon saltwater Rod Callander Memorial Aquarium. Both the 2013 Radiology Initiative and the Hematology/Oncology Improvement Project were made possible by community members' generous financial support.

Molecular Testing May Prevent Unnecessary Thyroid Surgery



During the LMH Development Council's Corporate Breakfast in May, Kenneth Parker, M.D., of Licking Memorial Otolaryngology, discussed the detection and treatment of thyroid disorders.

Many American adults will develop thyroid nodules at some point in their lives. Medical professionals have recently discovered that thyroid nodules are much more common than previously believed, but fortunately, the vast majority of these nodules are not cancerous. Kenneth Parker, M.D., of Licking Memorial Otolaryngology, discussed the detection and treatment of thyroid nodules at a Corporate Breakfast, sponsored by the LMH Development Council on May 7. Dr. Parker explained that LMH's advanced technology provides highly accurate testing that enables many patients to avoid unnecessary thyroid surgery to remove suspicious nodules.

Dr. Parker noted that thyroid nodules are one of the most prevalent conditions that he treats. "Up to 7 percent of adults in the United States have a nodule large enough to palpate, feel, or even see by the naked eye," Dr. Parker explained. "In addition, ultrasound studies have revealed that up to 67 percent of individuals have a thyroid nodule that is too small to be felt. Many nodules are discovered incidentally when patients have an ultrasound, computed tomography (CT) scan or magnetic resonance imaging (MRI) for an unrelated condition, such as a neck injury."

Most patients with thyroid nodules do not have symptoms; however, the most common symptom is a lump in the neck. Although nodules can develop at any age, they are more likely to develop with age. Compared to men, women are four times more likely to have a nodule. Fortunately, 95 percent of all nodules are benign. If a nodule is suspected of containing cancerous cells, the physician may order a fine needle biopsy to examine samples of the thyroid tissue. A fine needle biopsy uses a very thin needle to remove cells from the nodule and can often be performed in the physician's office, with or without a local anesthetic.

In general, Dr. Parker recommends a fine needle biopsy of the butterfly-shaped thyroid gland if the patient has the following risk factors:

- Large nodule over 1.5 cm in size, or 1.0 cm in size with additional risk factors
- Nodule hardness and immobility
- · History of thyroid cancer among primary relatives
- Radiation exposure to the head and neck (Routine dental X-rays are not a risk factor)
- Exposure to irradiated environments, such as Chernobyl (a concern for some military personnel)
- · Hoarseness with vocal cord paralysis
- Enlarged lymph nodes in the neck
- Presence of increased blood flow in the thyroid
- Presence of calcifications in the thyroid
- Nodules that appear to be spreading beyond the thyroid gland

If the fine needle biopsy results indicate that cancer is present in the thyroid, or the results are "indeterminate" (unclear), the patient's tissue can be sent to a molecular laboratory for genetic testing. There, advanced technology examines the cellular structure of the removed tissue for evidence of a malignancy.

"Nearly 20 percent of fine needle biopsies result in indeterminate findings," Dr. Parker said. "At many hospitals, those patients have to make the difficult decision whether to have surgery 'just in case' cancer is present. We are proud that we are able to offer our patients molecular testing which increases the accuracy of biopsy results, enabling many to avoid unnecessary surgery."

In the event that a patient's thyroid gland is surgically removed, the patient will need to take hormone replacement medications for life to regulate the body's metabolism and growth. Those who suspect that they may have a thyroid nodule or any other thyroid abnormality are encouraged to visit their physician to rule out a serious condition.

The LMH Development Council hosts four Corporate Breakfasts each year to share information about the Hospital with community leaders. The LMH Development Council, which is comprised of approximately 75 members, was established in 1987 to increase charitable giving to the Hospital and to promote good community relations.



Camp Feelin' Fine Provides Asthma Education and Summer Fun

For children with asthma, common summertime factors, such as freshly-cut grass, outdoor sports or playing with family pets, can result in the onset of alarming breathing difficulties. The Centers for Disease Control estimates 10 percent of children in the United States have asthma, making it one of the most prevalent chronic conditions among America's youth. Whether a child has been recently diagnosed, or has coped with the illness for some time, understanding the required treatments, physical limitations and lifestyle changes can be overwhelming. To help local children care for their asthma, Licking Memorial Hospital (LMH) sponsors Camp Feelin' Fine, an annual event that provides the knowledge necessary to manage the condition well.

Approximately 40 children attended this year's Camp Feelin' Fine on June 7 at Infirmary Mound Park, south of Granville. The youth participants spent the day learning more about asthma, exploring techniques to manage symptoms and interacting with others who also have the illness. Incorporating asthma education into games and activities keeps children engaged in the lessons because they have fun in the process," said Dr. Baltisberger, who is known as "Dr. Rick" to the campers. The Respiratory Therapy Department at LMH is staffed with state-licensed respiratory care professionals, who work under the direction of a physician and assist with the diagnosis, treatment and management of patients with pulmonary disorders.

"It is important to educate children about asthma medications and treatments, and help them identify the triggers of an attack, so they are prepared to successfully manage their symptoms," said Dr. Baltisberger. "Camp Feelin' Fine makes a positive impact on the lives of children with asthma, and I have been pleased to be part of it throughout the years."

Asthma is a condition that inflames and obstructs the airways in the lungs. Acute attacks, in which airflow is severely restricted, can be life-threatening, if left untreated. Symptoms of an asthma attack can include: coughing, irregular or labored breathing, wheezing, frequent clearing of the throat, and chest tightness. If a child who has not previously been diagnosed with asthma exhibits these symptoms, consult a pediatrician or family physician for a complete evaluation.



Ask a Doc – Adult Immunizations with Earl G. Haley, M.D.

Question: I am careful to follow our physician's recommendations for my toddlers' immunizations, but I wonder if my own immunizations need to be updated?

Answer: The short answer is yes. Immunization is a lifelong process to ward off preventable disease.

You should have receive some protection from vaccines that you received as a child; however, their effectiveness can fade over time. For this reason, your physician may advise a booster shot for some childhood diseases, especially since you are in close contact with small children.

Your immunization needs change as you age. For instance, senior citizens are at greater risk for different diseases, such as shingles, than when they were young children.

The Centers for Disease Control and Prevention (CDC) has established an immunization schedule that identifies which vaccines are recommended for each adult age group: The basic recommendations are below. Consult your physician for additional details.

Ages 19 to 49 years:

- Seasonal influenza 1 dose every year
- Pneumonia 1 to 3 doses if you smoke or if you have a chronic medical condition
- Tetanus/diphtheria/pertussis 1 dose of "Tdap" vaccine, and a dose for women with each pregnancy
- Tetanus/diphtheria 1 "Td" booster shot every 10 years after receiving the Tdap
- Hepatitis A 2 doses, 6 to 18 months apart for those at elevated risk (if previously unvaccinated)
- Hepatitis B 3 doses over 6 months for those at elevated risk (if previously unvaccinated)
- Human papillomavirus 4 (HPV4) 3 doses (given over a 6-month period) for women and men up to the age of 26 years
- Measles/mumps/rubella 1 dose for those born after 1957; a second dose may be recommended
- Chickenpox (varicella) may be recommended for those who never had chickenpox or received only 1 dose of vaccine

• Meningitis – 2 doses every 5 years for college students who live in a residence hall, and patients with certain medical conditions

Ages 50 to 64 years:

- Seasonal influenza 1 dose every year
- Pneumonia (for those who have never been vaccinated as an adult for pneumonia) 1 to 3 doses for smokers, or those with a chronic medical condition
- Tetanus/diphtheria/pertussis 1 dose of "Tdap" vaccine for those who have never been vaccinated as an adult
- Tetanus/diphtheria 1 "Td" booster shot every 10 years after receiving the Tdap
- Hepatitis A 2 doses, 6 to 18 months apart for those at elevated risk (if previously unvaccinated)
- Hepatitis B 3 doses over 6 months for those at elevated risk (if previously unvaccinated)
- Measles/mumps/rubella 1 dose for those born after 1957; a second dose may be recommended
- Chickenpox (varicella) may be recommended for those who never had chickenpox or received only 1 dose of vaccine
- Meningitis 2 doses every 5 years recommended for those with certain medical conditions
- Shingles (zoster) 1 dose for those over the age of 60

Ages 65 years and older:

- Seasonal influenza 1 dose every year (A high-dose vaccine is now available for patients over the age of 65.)
- Pneumonia 1 dose for those who have never been vaccinated
- Tetanus/diphtheria/pertussis 1 dose of "Tdap" vaccine for those who have never been vaccinated as an adult
- Tetanus/diphtheria 1 "Td" booster shot every 10 years after receiving the Tdap
- Hepatitis A 2 doses, 6 to 18 months apart for those at elevated risk (if previously unvaccinated)
- Hepatitis B 3 doses over 6 months for those at elevated risk (if previously unvaccinated)
- Chickenpox (varicella) may be recommended for those who never had chickenpox or received only 1 dose of vaccine

- Meningitis 2 doses every 5 years recommended for those with certain medical conditions
- Shingles (zoster) 1 dose for those over the age of 60

Although it is important for every adult to be properly immunized, it is especially crucial for the following individuals:

- Healthcare workers
- Caregivers (of children or adults)
- · Students living in residence halls
- Nursing home residents
- Patients with chronic illnesses (such as diabetes, asthma or heart disease)

- · Gardeners, farmers, or anyone who works with soil
- International travelers
- Women who are pregnant or planning a pregnancy

Modern vaccines are produced with inactivated or diluted viruses that cannot cause a patient to contract the disease. In some cases, patients may feel mild side effects that usually can be easily controlled with an over-the-counter pain and fever reliever, such as Tylenol, Motrin, or Advil. For the majority of people, the advantages of immunization greatly outweigh the possibility of mild side effects.

Quality Reporting to the Community Patient Story and Benchmarks for Stroke Care

Patient Story – Danny Brookover

When Danny Brookover awoke in the middle of the night on Halloween 2012, he thought, "Oh, no – not again." He was trying to walk to the bathroom, but had to lean against the wall for support. He went back to bed for more sleep, but when morning came, he told his wife, Sally, "I think that I have had another stroke. I better go to the hospital."

Just four months previously, Danny had suffered his first stroke at the age of 59. After spending the Fourth of July with family, he returned to his work as a concrete truck driver with unexplainable symptoms. He had driven his car to work into the wrong entrance, his speech was slurred, and he stumbled while he walked. Danny's coworkers recognized that he needed medical attention and sent him to a hospital. "I did not have any pain – I just lost my balance and could not walk or talk right," Danny recalled.

He received a CT scan of his brain, which identified an area of damage on his right side. Mourad Abdelmessih, M.D., of Mid-Ohio Neurology, examined Danny and confirmed that he had suffered an ischemic stroke on the right side of his brain that was caused by a blockage in the carotid artery. Danny began to take Plavix[®] to prevent a buildup of plaque and reduce his risk of future strokes.

Danny noticed some lingering effects from the stroke in July. His right arm tended to curl up, one side of his face drooped, and his speech was difficult to understand. Throughout the next four months, those side effects began to subside, until he awoke that Halloween night and realized that he was experiencing the same loss of balance he had in July.

Sally took Danny to the Emergency Department at Licking Memorial Hospital (LMH). Another CT scan of his brain revealed that a second stroke had occurred, this time on the left side of his brain, and he was admitted to LMH. Danny was visited by Linquan Sun, M.D., of Licking Memorial Neurology, in his patient room before being discharged to his home several days later. Even though Danny was not feeling well, he was impressed by the staff's attention to detail. "They made sure I was warm, and they came in and checked on me all the time. They took great care of me," he said.

In December 2012, Danny returned to LMH and Howard L. Reeves, D.O., performed surgery to clear the plaque buildup from his right carotid artery. In January 2013, a similar procedure was performed on his left carotid artery.

The family history is an important indicator of a patient's risk for stroke, and Danny knows that he is fortunate to have survived. "My grandfather died of a stroke in his 60s, and my dad died of a heart attack at the age of 67," Danny explained. "I do not want to go through this again, so I know that I need to take my prescriptions, see my doctor regularly and keep an eye on my blood pressure. Most importantly,

if I start feeling symptoms again, I know to go to the hospital immediately so that they may be able to reverse the stroke damage with 'clot-busting' drugs that can be used only within four and one-half hours from when the stroke first began."

As he recovers from the strokes, Danny has some difficulty with walking and uses a cane to steady his balance. Dr. Sun advised him that his mobility is likely to continue improving for up to one year after a stroke, so Danny is hopeful that he will be able to enjoy his favorite outdoor activities again soon.

Beginning rehabilitation as soon as it can be done safely can help improve recovery for stroke patients. Rehabilitation may include physical therapy, occupational therapy and/or speech therapy.

Ideal management of a patient who has suffered a stroke includes starting the patient on a blood-thinning medication (such as aspirin) while in the hospital. These medications should also be continued after the patient is sent home from the hospital. These medications can help prevent another stroke; however, in some cases, they may pose a higher risk for patients and should not be used. Stroke patients are also at higher risk for developing blood clots, known as venous thromboembolism (VTE). To help prevent this from happening, stroke patients should also receive protective medications, known as "prophylaxis," to reduce the potential of blood clot formation.

Patients with atrial fibrillation are at higher risk for suffering strokes. Due to an inefficient heartbeat, blood clots can form in the heart and then travel to the brain, leading to stroke. These patients should receive long-term blood-thinning medication to help prevent these clots from forming. LMH tracks the percentage of patients with atrial fibrillation who were discharged on a blood-thinner, as appropriate.

Another significant risk factor for stroke is high cholesterol. Stroke patients with high cholesterol should receive cholesterol-lowering medications (called statins) to take after discharge to help lower the risk for more strokes. LMH tracks the percentage of stroke patients with high cholesterol who were receiving statins at discharge.

Licking Memorial Health Professionals (LMHP) office-based physicians use evidence-based measures in order to provide excellent, quality care to patients. The American Stroke Association and American Heart Association recommend the use of blood-thinning medication in order to prevent clots from forming and to improve blood flow. Patient Story and Benchmarks for Emergency Care

Patient Story – Eschol Curl



When Eschol Curl became ill with a bad cough on December 31, 2012, he was grateful that the new Licking Memorial Urgent Care in Granville had recently opened. It was difficult enough to get a same-day appointment at his busy family physician's office on an ordinary day, but during the holiday season, especially on New Year's Eve, the wait could be

a few days. As a member of the Development Council at Licking Memorial Hospital (LMH) for approximately 20 years, Eschol knew that he could visit LMH's Urgent Care facilities in Granville and Pataskala without an appointment, seven days a week, except for holidays.

Eschol checked in at the Urgent Care's front registration desk, talked to a nurse about his symptoms and then was examined by Kevin J. Finley, M.D. "The waiting room was crowded, and I expected a long wait after I was taken back to the patient examining room. But Dr. Finley saw me within a few minutes, reviewed the nurse's notes about my symptoms and asked me some 'spot-on' questions that showed he was truly listening to me and concerned about my well-being," Eschol recalled. "Even though there were many patients to see that day, the staff was so efficient and caring that I did not feel rushed." Just 20 minutes after his arrival at the Urgent Care office, Eschol was on his way home, armed with a prescription from Dr. Finley to treat bronchitis.

Eschol visited LMH Urgent Care in Granville again on a cold Friday afternoon in January, just a couple of weeks after his New Year's Eve visit. "I had been cutting and stacking firewood in my yard, and I discovered a tick embedded on my chest a couple of days later," Eschol recalled. "Ordinarily, I would have removed the tick at home, but I was aware that some ticks that stay active in the winter can carry disease, and I wanted to ensure that it was removed properly." Jill M. Nicholson, M.D., extracted the tick carefully and assured Eschol that it was not a species that is associated with Lyme disease.

"The first time that I visited an urgent care facility was in 2011," Eschol said. "I also had a recurring cough then and needed to see a physician during a time that would fit into my schedule. I was able to see a physician at LMH Urgent Care in Pataskala with a very short waiting time. Two months later,

when I had a similar problem, I could not get an appointment with my family physician, so I returned to the Urgent Care in Pataskala. I like the fact that the Urgent Care physicians took time with me, asked the right questions, and carefully reviewed the information that the nurses gathered from me."

As a retired Vice President of Operations at State Farm Insurance, Eschol innately evaluates other businesses' customer service performance. "I was really impressed by the professionalism at both Urgent Care locations," he stated. "Both visits to the Granville office were during 'flu season,' and the staff members were quite busy. One time, Pat Lyons, a front desk registrar at the Granville office, was the first person to greet me, and even though there were many patients in the waiting room at the time, she attended to everyone's needs and was sensitive to their privacy during the check-in process. Both the Pataskala and Granville office staffs are always very cordial, professional and efficient."

Eschol has found visits to LMH's Urgent Care facilities are a time-saving convenience with high quality service. "I've had very good success with Licking Memorial Urgent Care. I do not go to a doctor very often, but if I need to, and mine is not available, I do not hesitate to visit the Urgent Care offices. I like their availability, hours and efficiency."

Through his membership with the LMH Development Council, Eschol had heard positive remarks from the community regarding the Urgent Care facilities, but did not have any personal experience with them until his first visit in 2011. "I was even more proud of my association with LMH after I had that visit and witnessed what they are doing for the community's residents," he said. "I am pleased and proud of how the Urgent Care facilities contribute to the community's health by making health care accessible and affordable."

Hours of operation are 9:00 a.m. to 8:00 p.m., Monday through Friday, and 9:00 a.m. to 5:00 p.m., Saturday and Sunday, closed on holidays. Licking Memorial Urgent Care – Pataskala is located at One Healthy Place, off State Route 16 in Pataskala. Hours of operation are 12:00 Noon to 8:00 p.m., Monday through Saturday, 12:00 Noon to 6:00 p.m., on Sunday, and closed on holidays.

LMH operates two urgent care facilities: Licking Memorial Urgent Care – Pataskala (which opened in 2009) and Licking Memorial Urgent Care – Granville (which opened in 2012). Patients are encouraged to visit Urgent Care rather than the ED when they have illnesses and injuries that are not life threatening, but need immediate attention, such as ear infections, minor fractures and minor animal bites. Urgent Care visits usually require less time and lower costs than visits to the ED.

Emergency angioplasty restores blood flow in a blocked heart artery by inserting a catheter with a balloon into the artery to open the vessel. The procedure has been proven to save lives during a heart attack, and it is most effective when performed within 90 minutes of the patient's arrival to the ED to minimize irreversible damage from the heart attack.

Patients who are seen in the ED and return home can sometimes develop further problems that warrant a return to the ED. LMH looks closely at these cases to evaluate appropriate patient treatment versus progression of the patient's condition. For this reason, LMH measures the rate of patients who return to the ED within 24 hours to ensure that patients have their conditions managed appropriately. LMH sets aggressively low goals for this measure, as listed below.
